## Pinsent Campsite General Rules



## Failure to comply with the General Rules could result in the group being asked to leave the site

- 1. Domestic animals are not permitted at Pinsent. Assistance Dogs are permitted.
- 2. Please respect the Pinsent curfew and ensure all your group are quiet between 23.00hrs and 07.00 hrs. If generators are used, they must not be operated during the Pinsent curfew.
- 3. Caravans and motor homes are not allowed to park at Pinsent for the purpose of overnight camping, unless a special dispensation is given by the Duty Warden.
- 4. The recommended speed limit for all vehicles on the access road to Pinsent is 15mph. The speed limit for the car park is walking pace. All vehicles and trailers must be parked in the main car park.
- 5. Vehicles are not permitted on the campsite. You may push your trailer to and from your site.
- 6. Hand trolleys and wheelbarrows must not be retained on camping areas and must be returned to the compound as soon as loading/unloading has been completed.
- 7. Please respect other people's camping sites and walk around them, rather than through them.
- 8. Ground fires are permitted in designated areas only. If in any doubt, please ask the Duty Warden for clarification. No fires are to be lit in or around the grassed camping areas and turfs must not be lifted. The campfire circle is for campfires only. No small fires are to be lit in this area.
- 9. Fallen wood may be collected from the ground around the site but it is strictly forbidden to take wood from live trees for any use.
- 10. Chain saws are not permitted at Pinsent.
- 11. Water points and the toilet block hand basins are not to be used for washing up.
- 12. All rubbish is to be removed from the site at the end of the camp/session. No plastic or other hazardous material should be burned.
- 13. Any damage/loss to equipment/property/facilities/ environment/trees will be charged to the group plus an administration fee.
- 14. Digging of pits or trenches for any reason is not permitted at Pinsent.
- 15. Use of the Roundhouse can be booked for 24-hour periods by groups camping. If the Roundhouse is not specifically booked then it is available for short-term, daytime use by all campers/users, but not for overnight use.
- 16. Under normal circumstances the use of trailing leads for supply of electricity to sites is not permitted. If trailing leads are required for a special purpose, then permission must be sought prior to the event from the Campsite Manager or Campsite Warden.
- 17. Alcohol/Drugs/Smoking. Persons under the age of 18 are not permitted to drink alcohol at Pinsent. Persons over the age of 18 should not consume alcohol so that they are incapable of looking after themselves. It is the responsibility of the Group Leader to supervise the consumption of alcohol at Pinsent. Smoking on site is at the discretion of the Camp Leader. Pinsent operates a Zero Tolerance Policy on the possession/use of illicit drugs or any illegal substance.
- 18. Hirers should ensure that proper consideration is given to the use of the road leading to the site. If necessary, a traffic management plan should be put in place.

## At the end of a booking, either camping or session:

- 1. All fires are to be extinguished and the ash cleared away and deposited in designated area. Any unused wood should be neatly stacked in an appropriate place
- 2. The toilet block is to be left in an acceptable state of cleanliness. Water heaters and taps must be turned off
- 3. All rubbish to be removed from site
- 4. Toilet block and Main Gates must be properly secured and checked
